SUPPLEMENTARY WATER ACCESS FOR MURRUMBIDGEE

12 October 2016

DPI Water has approved extension to the period of supplementary water access for the Murrumbidgee River System. This follows rainfall over large parts of the tributary catchment. Please refer to page 2 for supplementary access details and dates.

"In addition, all regulated river (general security) access licence holders may take water during this period of supplementary flows, if the uncontrolled flow (UCF) limits of their accounts permit. Licence holders are reminded that all diversions count towards the annual usage limit of 100% of entitlement (excludes trades into accounts).

Customers wishing to access supplementary water must place a complying water order using one of the following options:
